It is agreed upon that all tobacco stored on the premises shall be purchased from Leisure Life Tobacco Retailers, LLC (DBA Tobacco Town Cigar Lounge).

Members agree to adhere to the following **policies and procedures**:

1. Lockers will only be rented on an annual basis to customers 21 years of age or older.
2. Lockers can only be shared with one additional person.
3. Shared locker members must also submit a rental lease agreement & application.
4. Lease terms are month to month. The term of membership is for the remainder of the current calendar month and will automatically renew on the first day of the next calendar month unless notice of cancellation is received 30 days prior to cancellation. All leases expire end at the end of the calendar month.
5. Full monthly payment is due at the time of signing. Rental fee will be due monthly via cash or using the member's credit card subject to a 3% credit surcharge. Member agrees to provide credit card information and approval of reoccurring monthly charges.
6. Members will receive a 10% discount on all purchases. Members will also receive private VIP access to the lounge via the private rear entrance. A discrete door code will be assigned to members.

7. Two keys will be issued per locker. Keys must be returned at end of rental period. A fee of \$20 will be charged for each lost key.

8. We value your investment in fine cigars. It is our desire to store your cigars in perfect condition. Member understands that we continually monitor the temperature and humidity in our walk-in humidor for optimum storage conditions. However, we cannot be responsible for any products stored in personal lockers. Members are responsible for the contents of their locker and agree not to store any illegal products/items in locker. Management reserves the right to open any humidor locker for inspection and maintenance and cancel the rental agreement for any violations of this agreement. We ask you note the following: Occasionally, we will place a hygrometer in your humidor for the purpose of testing the temperature and relative humidity. Please do not remove these devices.

9. We reserve the right to close for private functions. We reserve the right to alter or change the locker lease agreement at any time.

10. Members are responsible for any damage to locker.

11. Lockers cannot be transferred.

12. Member will remove any items from locker at end of rental agreement. Items not removed will be disposed of after 30 days.

13. All locker rentals are final and non-refundable.

14. Locker members will receive priority status for special event invitations.

15. Terms and conditions of rental agreement, including fees, may change from time to time.
